How to Complete a Corporate Resolution - Fidelity

RESOLVED, that the MEMBER/DIRECTOR TITLE of the Corporation is authorized, for the account of this Corporation, and on such terms and conditions as he/she/they may deem proper, to borrow from LENDER (Financial Institution) sums of money; and to sign, execute, and endorse all such documents as may be

3. The resolutions shall continue to be in full force and effect until express written notice of its/their rescission, modification or termination has been received by the Bank. Any and all prior resolutions received and certified by the Bank shall continue to have full force and effect until the Bank receives such written notice.
